Certification of Establishment of Speed Limits on State Highways in Nevada

In Reply Refer to:

On November 28, 1995, the President signed the National Highway System Designation Act of 1995, section 205(d) of which repealed the National Maximum Speed Limit Compliance Program (NMSL) effective Friday, December 8, 1995.

On July 5, 1995, the Governor of Nevada signed Senate Bill 133. In that legislation, 1995 Nev. Stat. ch. 634, the Nevada Legislature, anticipating the repeal of the NMSL, authorized the Nevada Department of Transportation to establish speed limits on highways constructed and maintained by the department with said speed limits not to exceed 75 miles per hour. The department also was authorized to establish a lower speed limit where necessary to protect public health and safety.

In April of 1990, the Board of Directors of the Nevada Department of Transportation, pursuant to section 408.131 of the Nevada Revised Statutes, delegated to the director of the department all duties and responsibilities for the department not specifically enumerated by statute as a duty or responsibility of the board. With the knowledge of the impending repeal of the NMSL, the director of the department formed a speed limit task force to determine the proper posting of speed limit for the Interstate system as well as other State highways. Based on the work of that task force, which included consideration of the factors in the Manual on Uniform Traffic Control Devices for setting speed limits, a recommendation for speed limits on the Interstate and the National Highway System Routes has been made by the chief traffic engineer as shown in Table 1 (attached).

The recommendation of the chief traffic engineer is adopted. The listed speed limits are hereby established as the new speed limits for those routes listed in the attachment, effective when speed limit signs are changed but no earlier than December 8, 1995. All currently posted speed limits are hereby adopted and will remain in effect until the signs have actually been changed. Until such time as determinations are made and speed limit signs changed, all state highways with 55 miles per hour speed limits previously set by the National Maximum Speed Limit will continue to have a speed limit of 55 miles per hour.

Modification to Posted Speed Limits on State Highways

in Nevada due to Repeal of the National Maximum Speed Limit

On November 28, 1995 President Clinton signed a bill that repealed the National Maximum Speed Limit (NMSL). This repeal will take effect on Friday, December 8, 1995. The Nevada Revised Statutes, Section 484, requires NDOT to set speed limits on State Highways upon repeal of the NMSL. With the knowledge of the impending repeal of the National Maximum Speed Limit, a speed limit task force was established to determine the proper posting of speed limit for the Interstate system as well as other State highways. Based on the work of that Committee which included consideration of the factors in the Manual on Uniform Traffic Control Devices for setting speed limits, a recommendation for speed limits on the Interstate and the National Highway System Routes has been established.

It is recommended the speed limits shown in Table 1 (attached) be established as the new speed limits for those routes shown in the attachment, effective when speed limit signs are changed but no earlier than December 8, 1995. This recommendation is the first phase in the change of speed limits in Nevada. We will follow-up with subsequent lists until all State Routes have been reviewed and a speed limit recommendation is given.

The first phase of the speed limit lane change will occur on December 8, 1995 when all Interstate, both urban and rural, and four-lane divided highways will have the speed limits changed in the field. The remaining routes in Table 1 will be changed as field information is received on passing sight distance zones and curves. These routes will be changed as soon as additional striping and warning signs are installed. It is also understood that no new speed limit will take effect for the purposes of enforcement until the signs have actually been changed. Until such time as determinations are made and speed limit signs changed, all roads with 55 mph speed limits previously set by the National Maximum Speed Limit will continue to have a speed limit of 55 mph.
